

Time Line for the Beating of Richard O'Dell (Rich)

Christmas Day and Evening, 2012

O'Dell invited to family gathering at Dionne house on 7 Endicott Street by Linda Dionne
Party moves from Endicott Street to VFW on Pleasant Street
Yelling and Screaming breaks out; Bartender asks everyone to leave
Scuffle in parking lot between unknown persons/officers
O'Dell is beaten and calls 911
Drives to Dionne house on Endicott and takes Linda Dionne and her nieces home

Dec 28, 2012

O'Dell files complaint with Chief Rohmer and then Lt. Beaudoin over email and telephone
Lt. Beaudoin assigned to investigate and orders responding officers and officers present at VFW
to write reports of the incident

Dec 31, 2012 (Monday)

Beaudoin orders meets O'Dell in car in Framingham because O'Dell did not want to go to
Ashland Police Station

January 2013

Beaudoin goes on vacation

Jan 11, 2013

Beaudoin back; calls O'Dell
Dionne sister files sex harassment against Beaudoin
(charges later dropped-groundless)
O'Dell learns investigation is reassigned from Beaudoin
O'Dell learns Briggs is assigned to investigate

Feb 11, 2013

Briggs asks to meet O'Dell

Mar 12, 2013

O'Dell gives statement to Briggs at Town Hall

April 1, 2013

Rohmer fired
Email from Briggs – "Do you want to continue charges?"
No action visible to O'Dell on investigation

April – June 2013

July 1, 2013

Finding of no evidence; charges dropped

No meeting with Chief Doherty

No meeting with Town Manager – Purcell

No meeting with Town Manager - Schiavi

Lt. Beaudoin assigned. Between Friday and Monday Beaudoin orders responding and present to officers to write reports

Dec 31, 2012 (Monday)

Beaudoin meets O'dell in his car in Framingham because O'dell didn't want to go to the station and Beaudoin didn't want O'dell at the station.

Beaudoin on vacation

Jan 6/7, 2013

Beaudoin back; no call to O'Dell till Friday 1/11/13

Dionne sister files sex harassment against Beaudoin

(charges later dropped-groundless)

O'Dell learns Beaudoin is reassigned

Jan 11

O'Dell learns Briggs is assigned to investigate

Feb 11, 2013

Briggs asks to meet O'Dell

Mar 12

statement given to Briggs at town hall

April 1, 2013

Rohmer fired

Email from Briggs – “Do you want to continue charges?”

No action visible to O'Dell on investigation

July 1, 2013

Finding of no evidence; charges dropped

There was no meeting with Chief Doherty

No meeting with Town Manager – Purcell

No meeting with Town Manager - Schiavi
